Sun State has created this privacy policy in order to demonstrate our commitment to your privacy. We have adopted the following policies to safeguard your personal information.

This privacy policy applies to content hosted at [www.sunstaterollerderby.org](http://www.sunstaterollerderby.org) (the league's website). Sun State is not responsible for the privacy policies, practices, or content on websites that may link to or be linked from this website.

Sun State does not sell email addresses or any other information to third parties. Under no circumstances do we collect any personal data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, health, or sex life.

This privacy policy will inform you of what information our website may gather about you, how we use that information and with whom we share the personal information we gather.

#### **What Information our Website Gathers About You**

Sun State will on occasion collect user-submitted information such as name, email address and postal addresses to identify users and send notifications related to the use of the service (ie. event registration, presale merchandise orders etc).

#### **How We Use and With Whom We Share the Personal Information We Gather**

As a matter of policy, except where you are expressly informed otherwise, we do not sell, rent, share, trade or give away any of your personal information unless required by law. The information gathered is used to provide services (ie. event registration, merchandise sales etc) and is only provided to those league members operating those services.

#### **Email Inquiries, Responses, and Updates**

We use our website to give you the opportunity to contact us to ask questions, request information and materials, register or sign up for events, or provide comments and suggestions. We generally respond to any email questions that we receive. We may retain this correspondence to improve our products, services, and website, and for other disclosed purposes.

We retain contact information so that we can send individuals updates or other important information about our services and products. Occasionally these updates or other important information may be sent out by third parties on our behalf. Please be assured that any third party who contacts you on our behalf has agreed to provisions ensuring the privacy and security of any transferred information.

**Surveys**

From time-to-time we may conduct surveys. Participation in these surveys is completely voluntary and you therefore have a choice whether or not to disclose this information. Survey information will be used for purposes of monitoring or improving the use of and satisfaction with the website, and improving our customer service and product offerings.

**Information Implicitly Provided by You**

When you visit our website, certain information that does not identify you personally, such as your Internet Protocol ("IP") address, pages visited, referring domains, and browser types. This information is gathered for all users to the website and this information is used for the general administration of our website. Statistics about your visit are used for aggregation purposes only and help us improve the performance of our Website.

This website may contain links to other websites (ie. Facebook, Eventbrite, Tshirt Mill etc.). Sun State is not responsible for the privacy practices of other Websites. We encourage our users to be aware when they leave our website and to read the privacy policies of each and every website that collects personally identifiable information. This privacy policy applies solely to information collected by Sun State's website.

**Disclosure by Law and Protection of Sun State and Others**

If we are required by law to disclose certain information to local, state, federal, national or international government or law enforcement authorities, we will do so. We will also disclose information to third parties as necessary in order to comply with applicable laws and regulations. In addition, Sun State may share information in order to investigate, prevent, or take action regarding illegal activities or suspected fraud.

**Changes to Our Privacy Policy**

If we change our privacy policy, we will post those changes on our website so our users are always aware of what information we collect, how we use it, and under what circumstances, if any, we disclose it. If we are going to use users' personally identifiable information in a manner different from that stated at the time of collection we will notify users via email or by placing a prominent notice on our website.
